## INTERNATIONAL APPLICATION FORM

### TERMS AND CONDITIONS OF AIRCRAFT HIRE

- 1. All aircraft will be flown in accordance with Civil Aviation regulations and their associated NOTAMs, AlCs, Planning Manual, VFG and IFG, except in specific areas where these terms of hire specify more stringent requirements.
- 2. All flights in aircraft hired from Ardmore Flying School Ltd must be authorised by a duly authorised Ardmore Flying School Ltd flight instructor (except where the flight originates from a place other than Ardmore aerodrome, in which case the flight may be authorised by any New Zealand licensed flight instructor).
- 3. No warranty is given by Ardmore Flying School Ltd as to the fitness for flight of any of its aircraft nor its suitability for the intended flights by the hirer.
- 4. The hirer is responsible for ascertaining that the aircraft has current maintenance documentation before flight. Any maintenance, either routine or non-routine required during term of hire must be authorised by Ardmore Flying School Ltd (by collect phone call if necessary).
- 5. The hirer is required to have read and understood the aircraft's specific Pilot's Operating Handbook and operate the aircraft in compliance with this manual.
- 6. Ardmore Flying School Ltd will not be responsible for any costs the hirer may incur either through delay caused by malfunction of the aircraft or any other reason whatsoever.
- 7. The hirer is responsible for returning the aircraft to Ardmore in the same condition as at the commencement of hire (fair wear and tear excepted). The hirer will pay the costs of any repairs to, or replacement of the hired aircraft pursuant to this clause to the extent deemed by Ardmore Flying School Ltd to be necessary in its absolute discretion. This will include the insurance excess component deducted for that specific aircraft. Payment is to be made within seven days of receipt by the hirer of an itemised account of such costs and failing payment the hirer will pay interest levied thereof at the rate of 20% per annum.
- 8. The hirer is responsible for any third-party damage caused by negligent act or permission of the hirer or their passengers.
- 9. Only the duly authorised and licensed hirer of the aircraft may manipulate the controls of the aircraft during the term of hire.
- 10. The hirer shall record his/her flight time on cross country flights on the basis of the first hobbs meter reading and secondly, actual flight time and provide these times to Ardmore Flying School Ltd immediately on return to Ardmore.
- 11. If Ardmore Flying School Ltd believes for any reason that the hirer has acted, or is likely to act in a manner contrary to established conservative standards of airmanship or contrary to established terms of payment, it may in its absolute discretion, suspend or decline the right of the hirer to hire aircraft for any period it may consider.
- 12. A booking or any prior reservation of a particular aircraft constitutes a request only and does not constitute a right to that aircraft. Ardmore Flying School Ltd accepts no liability for any expense incurred in the event of any aircraft not being available (the decision being at Ardmore Flying School Ltd.'s absolute discretion) for the hirer's intended flight.
- 13. All aircraft hire is to be paid in on the day of the flight unless arranged by prior arrangement in writing with management.
- 14. All pilots wishing to hire an AFS aircraft must supply and have their details including licence, qualifications entered into ETA prior to having a flight request submitted.

## ADDITIONAL INFORMATION FOR ITINERANT PILOTS

- 1. A minimum of 3.0 hours' flight time (on average) per day.
- 2. All hirers must supply credit card details.
- 3. A 50% deposit of the total estimated flight time is required before departure
- Before departure, an Ardmore Flying School Category B flight instructor must sight all documentation, including current licences (including a current BFR, an appropriate medical, logbook(s) and ratings). If there is no history of flying with Ardmore Flying School, a dual flight check will be required.

#### DECLARATION

**Privacy** - Ardmore Flying School is required to collect and store information from this form to comply with the requirements of the Civil Aviation Authority, Ministry of Education (student statistical returns), New Zealand Qualifications Authority (Record of Learning registration), Tertiary Education Commission, Industry Training Organisations (ATTTO), Ministry of Social Development (confirmation enrolment and academic outcomes), and Inland Revenue Department (student loan interest rebate). In addition, when required by statute, Ardmore Flying School releases information to Government agencies such as the New Zealand

Police, Department of Justice, Ministry of Social Development, and the Accident Compensation Corporation (ACC). In signing this enrolment form you authorise such disclosure on the understanding that Ardmore Flying School will observe the general conditions governing the release of information, as set out in the Privacy Act 1993 and the Post-Compulsory Unique Identifier Code of Practice. Prior Criminal Offences - This issuance of a NZ CAA Licence is subject to a fit and proper person evaluation. A conviction on any criminal offence may restrict your ability to hold a licence. Accident Insurance - The Accident Compensation Corporation provides accident insurance for all New Zealand citizens, residents and temporary visitors to New Zealand, but you may still be liable for all other medical and related costs. Medical and Travel Insurance - International students (including group students) must have appropriate and current medical and travel insurance while in New Zealand. Ardmore Flying School provides medical and travel insurance through a New Zealand insurance company. Ardmore Flying School has assessed the policies provided by the insurance company. Insurance is compulsory for all

company. Aramore Flying School has assessed the policies provided by the insurance company. Insurance is compulsory for all international students studying at Aramore Flying School and will automatically be charged in addition to the quoted course cost unless and alternative insurance compliant with the Code of Practice has already been arranged.

Fees - In signing this enrolment form, you undertake to pay all fees as they become due, which includes Account Closure, Administration, and collection charges associated with debt recovery. Ardmore Flying School's credit policy on withdrawal and refund of fees is listed in the Student Training Contract. For clarity; the International Student Fee, Agent Fee and an Administration fee are not refundable if the student withdraws from the course at any time following the deposit of funds into the Ardmore Flying School's Trust Account.
